**CIRCULAR NUMBER 14**

**IMPORTANT REMINDER ON THE SUBMISSION OF LIQUIDATION CLAIMS**

- 1 SaXum Insurance Limited (**SaXum**) was placed into liquidation on 20 October 2016 by way of an order granted in the High Court, Johannesburg. SaXum is still in liquidation.
- 2 Policyholders are referred to **Circular Number 3(2) with its annexure** and **Circular Number 8** in relation to the process for lodging claims against the SaXum estate. These circulars can be accessed on <http://saxuminsurance.com/creditors/> along with all other circulars.
- 3 Policyholders who submitted valid insurance claims **after** the liquidation of SaXum are reminded that in order to receive payment for their claim from the SaXum estate they **must** also lodge a liquidation claim against the SaXum insolvent estate following the procedure set out in the above circulars. If a liquidation claim is not submitted in terms of **Circular Number 3(2)**, a policyholder's claim **will not be** considered for payment (if any) under the SaXum estate once the estate is finally wound up.
- 4 Please contact the SaXum office for assistance on completion of the liquidation claim form.
- 5 Policyholders who submitted valid insurance claims **prior** to the liquidation of SaXum but who have not yet received payment in relation to their claim **must**, as a result of the liquidation, also lodge a liquidation claim against the SaXum insolvent estate following the procedure set out in the above circulars.
